# Terms of Reference Micro-Alert Governance Group

## 1. Purpose

The purpose of the Micro-Alert Governance (MAG) group is to advise and direct the development, implementation and function of the Micro-Alert System (MAS), ensuring it is consistent with the requirements of participating healthcare facilities and is flexible and responsive to the changing epidemiology of multi-resistant organisms (MROs).

# 2. Accountability

MAG is a sub-committee of the Western Australian Multi-Resistant Organism (WAMRO) Expert Advisory Group. The role of WAMRO, related to the MAS, is to define the specific MROs and codes for the global MAS and endorse management policy for those MROs. WAMRO reports to the Healthcare Infection Council of Western Australia (HICWA) Executive Committee to the Assistant Director General Public and Aboriginal Health Division (ADGPAHD). The ADGPAHD will decide which issues should be taken to the Departmental Executive Committee; Health Executive Committee other relevant internal or external body.

# 3. Roles and responsibilities

- 3.1. To liaise with users of the MAS (hospital Infection Prevention and Control (IPC) personnel) and the Infection Prevention Policy and Surveillance Unit (IPPSU), on issues pertaining to the MAS.
- 3.2. To propose and evaluate changes to the MAS in liaison with Health Support Services (HSS).
- 3.3. To liaise with WAMRO on issues pertaining to MROs that require a micro-alert code.
- 3.4. To develop standardised rules for the initiation and modification of micro-alerts on the MAS.

# 4. Meeting frequency and modality

The group will meet annually and as required. Meetings will occur via Microsoft Teams or face to face meetings.

# 5. Notice of meetings

MAG members will be forwarded an agenda and associated papers at least five working days prior to the meeting.

#### 6. Quorum

A quorum will consist of the Chairperson and at least 50% of the membership.

### 7. Code of Conduct

#### 7.1 Code of ethics

The MAG will observe and comply with the WA Public Sector Code of Ethics. A copy of this document can be accessed at the public sector <u>website</u>.

#### 7.2 Conflict of interest

7.2.1 Each MAG member must declare any duality of interest in matters of concern to the MAG including:

- verbally declare any potential conflicts of interest (COI) at the commencement of each meeting on matters described on the Agenda
- alert the Chair of any potential COI that may arise during a meeting.

### 7.3 Decision Making

In making recommendations to WAMRO, the Group will aim for a consensus view.

#### 8. Secretariat

Secretarial support will be provided by the IPPSU, including responsibility for collation and circulation of the agenda, related papers and record of meeting. The Chair and the Secretariat will be responsible to promulgate information to the WA health system through established communication networks.

### 9. Chairperson

The Chairperson shall be elected annually from the membership. If the Chair is unable to attend a meeting he/she will nominate a proxy Chair.

# 10. Membership

### 10.1 The MAG is to comprise the following representation:

- IP&C staff and/or Clinical Microbiologist/ ID Physician from
  - Royal Perth Bentley Group
  - Fiona Stanley Fremantle Group
  - Sir Charles Gardiner Osborne Park Group
  - King Edward Memorial Hospital
  - Perth Children's Hospital
- Health Support Services (HSS)
- Western Australia Country Health Service IPC representative
- Private Hospital Infection Prevention and Control Specialist
- Secretariat IPPSU
- Other members may be co-opted as required.

### **10.2 Current Membership**

The current membership is listed in Appendix 1.

### 10.3 Proxy members

Members are to nominate a proxy to the secretariat if they are unable to attend a meeting. Proxy attendees have full decision-making rights.

## **10.4 Co-opted Members**

Representation may be requested from other specialty services or organisations as coopted members from time to time.

### 11. Review

11.1 The Terms of Reference and Membership of the MAG will be reviewed annually and / or as required and endorsed by the HICWA.
