What is <u>prednisolone</u> used for?

- Prednisolone is used for many conditions. It is used to suppress your immune system to prevent organ transplant rejection.
- Other conditions it is used for include: inflammatory diseases, autoimmune diseases, acute asthma, acute gout and croup.

What does <u>prednisolone</u> do?

 Prednisolone belongs to a group of medicines called corticosteroids. These medicines reduce inflammation and your body's immune system to prevent your body from rejecting an organ transplant.

How should I take <u>prednisolone</u>?

- This medicine is best to be taken WITH FOOD to prevent stomach irritation.
- If you are only taking this medicine ONCE a day, it is best to take it in the morning, to avoid insomnia or sleep disturbance at night.

What are the possible side effects? Not all side effects are listed – ask your health professional for more information

- Nausea, vomiting
- Diarrhoea
- Constipation
- Headache
- Increased or decreased appetite
- Infection

 This medicine can affect your mood or cause problems with sleeping. If these become troublesome, inform your doctor.

Important information

- If you are taking this medicine for longer than 2-3 weeks, then do not stop taking it abruptly, unless advised by your doctor. If it is necessary to slowly reduce the dose of prednisolone before stopping, your doctor will advise you of this.
- If you develop signs/symptoms of infection (e.g. temperature >38°C, fevers/chills/rigors, sore throat, cough, muscle/joint aches) or of an allergic reaction (e.g. rash, lip, tongue or neck swelling, difficulty breathing), SEEK MEDICAL ATTENTION IMMEDIATELY.
